



# BEARER SPECIAL PROMOTION 5H60D17PF (FEB 2024) TERMS & CONDITIONS

These Terms and Conditions apply to the Bearer Special Promotion ("Promotion") and supplement the <u>Bearer Contractor Agreement v1.0.110 - March 2023</u> ("Contractor Agreement"). By participating in this Promotion, participants acknowledge and agree to these Terms and Conditions, including the following stipulations and clarifications:

#### 1. Nature of Agreement:

This is not:

- i. an employment agreement and does not create an employer and employee relationship between you and Bearer or any party affiliated with Bearer.
- ii. a joint venture agreement.
- iii. a partnership agreement.
- iv. a principal agent agreement.

#### 2. Voluntary Participation:

Accepting the Promotional Offer and agreeing to the terms does not create any obligations for you to use the Bearer Platform or provide your services to Bearer at any time. Use of the Bearer Platform is completely at your discretion.

#### 3. Eligibility and Covered Areas:

- Participants must go and stay online for at least 5 hours (300 minutes) a day between
   9:00 to 18:00 on weekdays (Monday to Friday) in Melbourne CBD area (Postcodes:
   3000, 3001, 3004, 8001) to be eligible for the \$60 gift/e-gift card payment.
- Participants will receive 83% of the original order amount for accepted delivery requests during the Promotion.
- Additional rewards include complimentary Bearer merchandise, priority access to jobs and \$25 Axil Coffee voucher.

#### 4. Order Origin and Destination:

The origin of orders will be Melbourne CBD and surrounding suburbs, with destinations varying up to 60 km from the origin address, depending on the chosen Mode of Transport.

- To go online, participants must log into the Bearer Mobile App, turn the toggle switch to Online, choose their Mode of Transport, and confirm.
- To stay online, they must keep the app open and running on-screen; *minimizing the app will disrupt the online status*.
